- ❖ Unload and set up are the responsibility of the vendor. Take down and removal are the responsibility of the vendor.
- ❖ We take precautions to keep the grounds safe. Be sure all lightweight valuables are secured at night. Canopies to enclose a booth are suggested in all locations, outside or inside the pavilions.
- ❖ Electricity is available. No extensions cords are provided. Use of 110-120-volt electrical outlets is available.
- ❖ Please let us know if you need additional tables and/or chairs \$15 per set.
- ❖ Please keep your display within the confines of your booth space. Do not block or crowd your neighbor, there is plenty of room.
- ❖ The vendor will not deface, injure, or damage any structure, floor, walls, and/or materials provided by the Missouri State Fairgrounds facility. Including drapes, frames, tables, chairs, etc. Vendors

will be held liable for any destruction and pay the Missouri State Fairgrounds their assessed value for any damages occurred.

- ❖ Please remove all trash, boxes, rubbish, papers or products at the end of the event. Use the trash bins and trash dumpsters provided by the fairgrounds. Do not use pens or leave trash in pens. Pens may be used to store products for \$10 per pen.
- ❖ Vendors may not operate combustible engines indoors or under any pavilions.
- ❖ No additional food vendors without prior permission.
- ❖ Any equipment with a battery, batteries must be disconnected when not in use.
- ❖ No brokering or subletting of vendor space. Reserved space is for the use of the client.
